Annual Firth Fireworks Show – June 20

The annual Firth Fireworks Show will be Saturday June 20 at dusk at the ballfields. The show will be put on by Pyro Magic Fireworks. The Village Board asks that those watching from the ball fields practice social distancing. (Sponsored by the Village Board).

COVID-19 Response

Since the beginning of the COVID-19 outbreak, the Village Board has been monitoring local, state and federal health guidelines as well as heeding the advice of the Village attorney and the League of Nebraska Municipalities. At times this has led to some difficult and unpopular decisions. The Board has worked very hard to make wise decisions for the health and safety of Village residents, Village employees, and the Firth community. The Board understands the frustrations with this abnormal year and asks for your patience and understanding as there is most often more to these decisions than it appears.

Firth Park

At this time the park equipment and restrooms remain closed. CDC guidelines for opening park equipment and public restrooms call for disinfecting the equipment at least several times each day. Firth does not have the staff to disinfect equipment and clean restrooms several times a day or on evenings or weekends. The Village Board understands this is an unfortunate situation and that everyone wants to get back to normal. The Board will continue to re-evaluate the park situation on an ongoing basis.

Firth Splash Pad

The Village Board has decided to keep the splash pad closed for 2020. There is no way the Village can monitor crowd size or social distancing. Having the splash pad open would also draw large crowds from other communities which could potentially bring a greater opportunity for the spread of COVID-19 to the Firth community. With the potential health issues due to COVID-19, the decision has been made leave the splash pad closed for 2020.

Firth Ball Fields

Beginning June 3, the Village is allowing the NT Softball league to use the ball fields. NT is responsible for all cleaning and disinfecting of restrooms and equipment and monitoring group size and social distancing while ball fields are in use. Every person involved with NT or a competing team must sign a waiver regarding COVID-19 issues before being allowed at the ball field. This is the suggested statewide policy due to COVID-19. All other leagues or teams not playing with NT Softball are not allowed to use the fields.

Firth Fun Day Rescheduled for 2021

Due to the COVID-19 situation, and the health and safety of the Firth community, FACET has made the difficult decision to reschedule Firth Fun Day to 2021. The term for a Village Trustee is 4 years. Village Board meetings are the 1st Tuesday of each month and are required for all Trustees to attend. You must be a resident of the corporate limits of Firth and be a registered voter in Lancaster County to be a candidate for Village Trustee.

Firth Zoning Code update

The Planning Commission is currently working with FiveRule Rural Planning to update the Village Zoning ordinance. The committee is currently reviewing the final zoning document draft. There will be a public hearing on the final document at the July 28 Planning Commission meeting and the August 4 Board meeting. It is anticipated the updated zoning ordinance will be adopted in August 2020.
