It was moved by Eric Mercier, seconded by Jason Cooper, to approve pay request #4 from Sargent Drilling, in the amount of \$215,238.15, for the well project. Roll call vote: 5 Yeas, no Nays. Motion carried.

It was moved by Todd Carlson, seconded by Eric Mercier, to approve presented bills to be paid, (including the regular Norris Public Power that will come later in the month.) Roll call vote: 5 Yeas, no Nays. Motion carried.

Dave Hansmeyer gave the monthly maintenance report. He gave an update on the well house construction issues that are being corrected. The lift station pumps will not be in for another 4-6 weeks. The loaner pump is working fine.

The Village insurance company LARM has determined the damage to the truck incurred on December 22, 2022 is enough to total it out. The Village has decided to keep the truck and have a flatbed installed.

There was a discussion regarding the brush dump and several different options for operation were talked about.

Finalizations will be made for the scheduled Firth clean up day for May 6. Advertising the clean up day will begin in March.

Nuisance properties and unlicensed vehicles will be identified and compliance letters sent out in March.

The board is still waiting on a quote for painting the current basketball court for basketball and pickleball games.

There was nothing new to report on a possible Welcome to Firth sign.

The Board may consider replacing the community center tables and chairs that are now 14 years old. Several chairs have broken in the last month.
