Firth Road mill and overlay

The Village has entered into an interlocal agreement with Lancaster County for the mill and overlay of Firth Road. The entire project will go from 68th Street to the Firth Fire Station. The Village project cost for inside of Firth limits is \$122,298.73. The project bid states the project will be completed by November 1.

Recycling Issues

The Firth Recycle Drop-Off site is provided through an interlocal agreement with the City of Lincoln. The City of Lincoln provides the bins and schedules all pickup times. Please note: ALL recyclable items MUST be placed in the appropriate bins. ALL cardboard boxes MUST be flattened before placing in a bin. There have been issues with recyclables being left on the ground. This creates a littering problem. If you come to the recycle center and the bins are full please take your items back home and come back another time. Or take them to a different Recycle Drop-Off site. If the littering issues continue the Village will consider closing the Drop-Off site.

New Trees in the park

In anticipation of the arrival of the Emerald Ash Bore, three large ash trees removed from the main park last fall. The total of large ash trees removed from the park since 2017 is six. 2 new maple trees were planted in 2017. In April four large trees of differing varieties were moved into the park. They include a Bald cypress, Red Maple, Chinkapin Oak, and a Kentucky Hybrid Elm. All four will become very large shade trees. The Village was awarded a tree grant from the NRD and will be reimbursed \$1,800 toward the tree replacement cost.
